	Question / Inquiry	Program Response
1.	Please provide a thorough description of your program (250 words max)	The student interns are a vital and essential piece of the Office of Equity, Social Justice and Multicultural Education. They are the outward facing student that represents our office and we call them an Equity Scholar Activist Intern. Their responsibilities are more than the average interns but some of their responsibilities are outreach, social media, class presentations, tabling, event planning, event set up, speaking, leadership development, student mentor, promotional materials creation, and student representative at meetings. Each intern will culminate in hosting a campus wide event with a speaker that focuses on equity and social justice that usually results in about 100 students in attendance.
2.	Please provide how many students are actively engaged in the program. Backing it up with data will help.	Each student intern will do a class presentation once a week so if there are 2 student interns X 30 class members X 36 weeks, that equals to ~2,160 student contact. Also, with the culmination of each large event that they will produce roughly 100 students will attend. Moreover, students are constantly working with students in our office so for the whole year, the student interns will interact with about 20 students per week so that can possibly interact with about 1,440 students in the academic year. Overall, direct contact of students will be about 3,800 students throughout the year.
3.	Why is your program important and what is the rationale behind having this program on campus? (250 words max)	Our program is the utmost important because the mission and values of De Anza College include equity, social justice and multicultural education and that is exactly what we provide for the campus. In order to close the equity gaps we must put more emphasis on those underserved, marginalized populations so that they feel welcomed and at home on our campus. Lastly, many students are unaware of our programming and resources on campus and with our programs and interns, this can meet that need to bring awareness to the students about equity, social justice and multicultural education. We bring cutting edge speakers and workshops to the campus that contributes to the equity consciousness and mindedness on campus.
4.	How will your program expand students' perspectives and positively impact their lives and the community? (250 words max)	Our programming is bringing awareness to the campus about equity, social justice and multicultural issues that the students are experiencing and facing on/off campus. This programming shows that the campus cares about them and they see themselves in the speakers and workshops we provide. The impact is that they will be more conscious and connected to the campus and their communities that they live in.

Implementing a student survey and sharing the results with DASB will be beneficial for our review process.	Every year we always conduct a student intern evaluation so that we can improve the experience of the student intern. It is an oral and written feedback that is provided by the office so the interns can improve the student intern experience. After each event we have a google survey that measures if the event/workshop met the goals of the students.

Also, we have Student Equity money, that is primarily for other programming in our office like High Impact Practices, Equity Core Team mini projects and Lit Lunch. These are programs that different from the programming of the intern’s events. The Office of Equity events focuses on faculty and staff practices that help to build capacity across campus to ensure student success.

(250 words max)</p>	<p>Our programming is unique because we promote in all of our programming equity, social justice, diversity, inclusion and intersectional solidarity. There are programs that promote equity but the difference between our programs and other programs is that we focus on bringing quality equity programming that fosters equity consciousness and new and innovative equity strategies for the campus. We are the Office that the campus looks to for equity innovations. The Office of Equity events focuses on faculty and staff practices that help to build capacity across campus to ensure student success.</p>

(250 words max)</p>	<p>Our office does a great job of advertising and promoting our events but we definitely have room to grow. Here is our plan to promote to the general student population. We have a weekly newsletter that goes out to the campus specifically to our 700 people list. Our student interns post on Facebook and Instagram every other day about events coming up and they will do a class presentation every week to various classes in different departments and divisions. We also promote using the De Anza website events page for further advertising to the entire community. We often work with clubs that meet in our office and also promote to DASB and ICC to share our events and get involved. Lastly, we promote our events to shared governances and they promote to their constituents.</p>

(250 words max)</p>	<p>We are the Office of Equity, Social Justice and Multicultural Education so our mission is “The Office of Equity, Social Justice and Multicultural Education promotes — through programs and services — an academic, cultural and social environment that provides equity, social justice and academic success for all members of the De Anza College campus community. It supports the district and college missions, which consider diversity an essential component of student education in the 21st century. The Equity Office takes this charge seriously.
