Title: Preparation for the Senate Budget Deliberations

This item is to prepare for the upcoming Senate budget deliberations by debriefing on Finance's budget deliberations, reporting on the answers to the follow-up questions, and clarifying any questions about the Senate budget deliberations.

Presenter: Grace Lim Time: 15 minutes

- Hyon Chu asked if the first meeting with the Senate when they invite the budgeters to speak.
 - Dennis replied they would be invited to speak during the second Senate Budget Deliberation meeting and explained the Senate Budget Deliberation timeline.
- Further discussion occurred.
 - Dennis confirmed the spreadsheets will go out with next week's Senate agenda. He also shared how the budgeter comments will work during the Senate meeting.
 - Anthony shared the Honor's program replied to his email and said they get about 100 students attending their Symposium.
 - o Grace brought up Cross Cultural partners clarified the professional services they are asking for is to update an operating system.
 - Dennis and Lisa confirmed DASB is not allowed to fund that because it would be paying a district employee which conflicts with employee contracts.
 - O Grace reminded Senators to email any questions they have about programs to their budgeters. She also shared Interns are not obligated to attend the Senate Budget Deliberations, but they are encouraged to attend especially if they are running for Senator. She also asked everyone to come prepared. She also confirmed interns are allowed to speak during the Senate deliberations but not vote.
 - Hyon Chu shared that the Senate Budget Deliberations will go pretty late and to be prepared.
