

**The Coronavirus Aid, Relief and Economic Security Act Higher Education  
Emergency Relief Fund  
Emergency Financial Aid Grants to Students  
Reporting for Student Portion of the CARES Act Emergency Relief Fund**

**Report for April 10th, 2022**

The Coronavirus Aid, Relief and Economic Security Act (“CARES Act”) of March 27, 2020, directs institutions receiving CARES Act funding to submit a report to the Secretary of Education describing the use of funds distributed from the Higher Education Emergency Relief Fund (“HEERF”).

The CARES Act requires institutions to use no less than 50% of the HEERF allocation received from the CARES Act to provide Emergency Financial Aid Grants to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student’s cost of attendance such as food, housing, course materials, technology, health care and child care).

On April 9, 2020, the Department published documents related to the Emergency Financial Aid Grants, including a [letter](#) from Secretary Betsy DeVos, a form [Certification and Agreement](#) for signing and returning by institutions to access the funds, and a list of [institutional allocations](#). On May 6, the department published [further guidance and requirements](#) for disclosing the following information.

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

**De Anza College signed and submitted the Certification and Agreement form on April 17, 2020.**

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students.

**On April 25, 2020, De Anza College received \$3,617,629 to be distributed as Emergency Financial Aid Grants to students. DeAnza has been allocated funds from CRSSA, \$3,617,629 and HEERFIII (American Rescue Plan) \$12,664,736 to also be distributed as Emergency Financial Aid Grants to students.**

4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

**While HEERF student share dollars are not considered Title IV financial aid, the Department of Education's April 21, 2020 guidance states that students must meet requirements in Section 484 of the Higher Education Act of 1965 in order to receive HEERF emergency grants. Based on the number of students we have awarded Title IV aid, the total number of students potentially eligible to receive Emergency Financial Aid Grants is approximately 10,250.**

5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

**The college has determined eligibility for Emergency Financial Aid Grants based on need as determined by eligibility for the Pell Grant, with the award based on the Expected Family Contribution (EFC) determined by the FAFSA, as follows:**

- **Eligible students with an EFC of 0-\$2,000 up to \$1500 per quarter**
- **Eligible students with an EFC of \$2,000-\$4,000 up to \$1000 per quarter**
- **Eligible students with an EFC of \$4,000-\$5,200 up to \$750 per quarter**

**Students can submit an emergency fund application to be considered for the grant. The campus financial aid office has the discretion to increase the amount of the award as warranted by the application.**

**Before June 1, 2020, the college used the following criteria to determine eligibility for grants to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and childcare).**

- **Submitted the college's Emergency Cash Grant Application**
- **Completed FAFSA application and met Title IV eligibility under Section 484 of the Higher Education Act of 1965:**
  - **U.S. Citizen or eligible noncitizen**
  - **Registered with Selective Service (males only)**
  - **Valid Social Security number**
  - **High school diploma, GED, or completion of high school in an approved home school setting**
  - **Be enrolled or accepted for enrollment in an approved degree or certificate program**
  - **Not be enrolled in elementary or secondary school**
  - **Be making Satisfactory Academic Progress (SAP)**
  - **Submit Statement of Educational Purpose (if applicable)**
  - **Not be in default on Title IV grants or loans**
  - **Actively enrolled at the time of application and disbursement in a minimum of 0.5 units**

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

**De Anza College took the following steps to ensure compliance in awarding and disbursing CARES Act Emergency Funds to students**

- **April 24, 2020: The college updated the Emergency Cash Grants application to be in line with CARES Act requirements. The application is posted on the college website and linked from other locations on the website.**
- **May 4, 2020: The college released its first disbursement to students, with additional disbursements following on a weekly basis**
- **Students are notified by email when funds are disbursed or if an application is denied.**
